





About us

The East African Civil Society Organizations' Forum, (EACSOF), was founded in 2007 as an autonomous umbrella body of Non-Governmental Organizations (NGOs) and civil society organizations, (CSOs), in East Africa. Since its founding, EACSOF has been working to strengthen the institutionalization of the relationship between East African CSOs and the Community, (EAC); build a critical mass of knowledgeable and empowered civil society in the East African region, in order to foster their confidence and capacity in articulating grassroots needs and interests in the East African Integration Process; and ensure that East African citizens and their organizations work together to play a more effective role in the integration process through building stronger citizen organizations that respond to citizens needs and hold duty bearers to account.

EACSOF's role is also anchored in the provisions of the EAC Treaty. Article 1 of the Treaty defines civil society, and the definition is consistent with the character and ethos of EACSOF, Article 7 elaborates the operational principles of the Treaty by clearly highlighting that the principles that shall govern the practical achievement of the objectives of the Community include – people- and market-driven cooperation.

Article 128 enjoins the Partner States to provide an enabling environment for the private sector and civil society to take full advantage of the Community. Furthermore, consistent with Article 124 (4), which highlights that the Secretary General shall provide a forum for consultations between the private sector, civil society organisations, other interest groups and

appropriate institutions of the Community, EACSOF is CSO representative in the EAC Dialogue Framework, arrangement comprising CSOs, PSOs and the EAC.

- Strengthen the citizens' civic competence and confidence by enabling citizens to know their rights and obligations- and to support them to organize in effective CSO as well as national platforms through which they would be able to assert those rights.
- Ensure Citizen Centered Policy Development and Implementation at National and Regional Levels regarding Democratic Governance; Peace and Security; Social and Economic Justice; Agriculture, Natural Resources, Environmental Protection and Climate Change; and Mainstreaming Science and Technology.

Institutional Profile

EACSOF draws its membership from Civil Society Organizations including Non-Governmental Organizations, Community Based Organizations, Faith Based Organizations, and Networks and Coalitions of such organizations situated within the East Africa Community Member States.

The Governing Council of EACSOF chapters has two seats on the Governing board of EACSOF. It is important that each country sends persons who have a mix of expertise to provide strategic guidance and to foster public confidence in the institution. EACSOF works to ensure that it builds a strong but 'hands off' Governing Council that effectively oversees the Secretariat and ensures that it delivers efficiently and effectively on agreed policies and programmes. At the country level, the Country Chapters will develop a strong governance system that allows for accountability and oversight so that there is strong linkage between the regional and the national governance mechanism.

The EACSOF secretariate is based in Arusha Tanzania. It is led by an able Executive Director who oversees the secretariate operations, resource mobilization and implementation of programs. The team at the secretariate consists of a program officer, administrative officer, and finance officer. At the national level, the EACSOF Burundi chapter is hosted by ACOPA Burundi; the Kenya chapter is hosted by Collaborative Centre for Gender and Development (CCDG); the Rwanda Chapter is hosted by Rwanda Civil Society Platform (RCSP); the Uganda Chapter is hosted by Uganda National NGO Forum; and the Tanzania Chapter is hosted by NACONGO. The national chapters are independently registered as autonomous EACSOF chapters linked to the regional Secretariat through the Governing Council.

Achievements

Since its founding in 2007, EACSOF has registered several significant achievements:

- Advocated for the Consultative Dialogue Framework (CDF) for engagement between EAC, civil society organizations, private sector organizations and other interest groups, whereby EACSOF has been mandated as the focal point for CSO voices in the integration process.
- Spearheading the engagements on the CSO Operating Bill with an aim to improve the CSOs Operating Environment in East Africa
- High level advocacy on issues pertinent to regional integration including the civic space, business operating environment, trade.

- Delivering strong statements on pertinent issues.
- Development of policy briefs on Governance practices in the EAC Partner states.
- Formation of strong and varied networks, partnerships and alliances with organizations including PALU, EALS, EASSI, African Child Policy Forum, EASAFF, Tax Justice Network, and SEATINI among others.
- Skills building on various topics including but not limited to human rights, good governance and policy engagement, civil society participation in trade negotiations.

Challenges

Opportunities

Member organizations encouraged to include EACSOF or EAC issues as part of their own strategic plans to booster their commitment to the process.

There are opportunities for inter-regional networking, e.g. EACSOF with WACSOF;

Establishment of the East African Civil Society Academy to boost capacity building among CSOs in the region.

Increased membership, participation and joint resource mobilization.

Expedite the ratification of African Charter on Democracy, Elections and Governance (ACDEG) and develop a monitoring and reporting mechanism on good governance.
